LOT LINE ADJUSTMENT 2022-01 YORBA LINDA WATER DISTRICT

Summary: A request to reconfigure and merge the common property lines between four existing parcels of land located on the northwest side of Fairmont Boulevard and west of Little Canyon Lane, in the R-ML (Residential Medium-Low Density) and OS-G (Open Space General) zones. The lot merger proposal would result in a reduction of the total lots from four to three.
