

**RESOLUTION NO. 2022-5807**

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YORBA LINDA, CALIFORNIA, AUTHORIZING THE CITY MANAGER TO EXECUTE AGREEMENTS WITH THE CALIFORNIA DEPARTMENT OF TRANSPORTATION FOR THE YORBA LINDA-PLACENTIA MULTI-AGENCY ACTIVE TRANSPORTATION PLAN**

**WHEREAS**, The California Department of Transportation (Caltrans) announced a call for Sustainable Transportation Planning Grant (STPG) applications for Sustainable Communities Competitive and Strategic Partnerships Grants; and

**WHEREAS**, the City of Yorba Linda (lead agency), the City of Placentia, and the Placentia-Yorba Linda Unified School District (PYLUSD) will collaborate to develop a comprehensive Active Transportation Plan (ATP) that incorporates identified bicycle and pedestrian improvements, Safe Routes to School (SRTS) and multi-use trail plans; and

**WHEREAS**, the City of Yorba Linda submitted a competitive grant application to the California Department of Transportation for the proposed project titled the Yorba Linda-Placentia Multi-Agency Active Transportation Plan; and

**WHEREAS**, Caltrans provided notice that City of Yorba Linda submission was conditionally approved for award of grant funding provided certain conditions are met; and

**WHEREAS**, the City Council of the City of Yorba Linda is eligible to receive Federal and/or State funding for certain transportation planning related plans, through the California Department of Transportation; and

**WHEREAS**, a Restricted Grant Agreement is needed to be executed with the California Department of Transportation before such funds can be reimbursed through the Transportation Planning Grant Program; and

**WHEREAS**, Whereas the City of Yorba Linda wishes to delegate authorization to execute these agreements and any amendments thereto to the City Manager of the City of Yorba Linda; and

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Yorba Linda resolves as follows:

The City of Yorba Linda authorizes the City Manager, or designee, to execute all Restricted Grant Agreements and any amendments thereto with the California Department of Transportation.
