A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YORBA LINDA, CALIFORNIA, APPROVING THE SUBMITTAL OF THE LAKEVIEW AVENUE WIDENING PROJECT FROM ORIENTE TO BASTANCHURY ROAD (SI201003) TO THE ORANGE COUNTY TRANSPORTATION AUTHORITY FOR FUNDING UNDER THE COMPREHENSIVE TRANSPORTATION FUND PROGRAM

- **WHEREAS**, the City of Yorba Linda desires to implement the transportation improvements listed below; and
- **WHEREAS**, the City of Yorba Linda has been declared by the Orange County Transportation Authority to meet the eligibility requirements to receive Measure M2 "Fair Share" funds; and
- **WHEREAS**, the City's Circulation Element is consistent with the County of Orange Master Plan of Arterial Highways; and
- **WHEREAS**, the City of Yorba Linda will not use M2 funds to supplant Developer Fees or other commitments:
- WHEREAS, the City of Yorba Linda must include all projects funded by Net Revenues in the seven-year Capital Improvement Program as part of the Measure M2 Ordinance eligibility requirement; and
- **WHEREAS**, the City of Yorba Linda will provide a minimum of 25% in matching funds for the Lakeview Avenue Widening Project as required by the Orange County Transportation Fund Program Guidelines; and
- **WHEREAS**, the Orange County Transportation Authority intends to allocate funds for transportation improvement projects within the incorporated cities and the County; and
- **WHEREAS**, the City of Yorba Linda authorizes a formal amendment to the seven-year Capital Improvement Program to add projects approved for funding upon approval from the Orange County Transportation Authority Board of Directors.
- **NOW, THEREFORE, BE IT RESOLVED** by the City Council that the City of Yorba Linda hereby requests that Orange County Transportation Authority allocate funds in the amounts specified in the City's application to said City from the Comprehensive Transportation Programs. Said funds, if approved, shall be matched by funds from said City as required and shall be used as supplemental funding to aid the City in the improvement of the following street(s): Lakeview Avenue.
