AMENDMENT NO. 3 TO AGREEMENT FOR LANDSCAPE MAINTENANCE SERVICES WITHIN LANDSCAPE MAINTENANCE ASSESSMENT DISTRICT PACKAGE B – HIDDEN HILLS WITHIN THE CITY OF YORBA LINDA

THIS AMENDMENT is made and entered into this 20th day of September, 2022, by and between the City of Yorba Linda, 4845 Casa Loma Avenue, Yorba Linda, California 92886, a municipal corporation of the State of California (hereinafter referred to as "City"), and Merchants Landscape Services, Inc. (hereinafter referred to as "Contractor") (collectively, the "Parties").

WITNESSETH:

WHEREAS, the City and the Contractor entered into an Agreement for landscape maintenance within Landscape Maintenance Assessment District Package B – Hidden Hills within the City of Yorba Linda dated July 1, 2019 (Agreement); and

WHEREAS, the Agreement allows to renew the agreement for up to two (2) additional one-year term extensions; and

WHEREAS, the City and Contractor entered into Amendment No.1 to the original agreement dated July 1, 2022, to extend the agreement for one (1) additional month and to increase the agreement sum to provide additional compensation for services rendered by Contractor during the extended term; and

WHEREAS, the City and Contractor entered into Amendment No.2 to the original agreement dated August 1, 2022, to extend the agreement for one (2) additional months and to increase the agreement sum to provide additional compensation for services rendered by Contractor during the extended term; and

WHEREAS, the Contractor requested an increase in unit costs based on the Consumer Price Index (CPI) pursuant to the extension of term of contract clause in Section 3.1.2.1 of the Agreement; and

WHEREAS, the City and Contractor agreed to a CPI based increase of six and eight-tenths percent (6.8%) based on the percentage change in the CPI for the preceding year for unit costs; and

WHEREAS, the City intends to extend the agreement for nine (9) additional months pursuant to the extension clause in Section 3.1.2.1 Extension of Term of Contract of the Agreement; and

WHEREAS, the City intends to delineate the contract compensation increase amount for the extension term based upon the City's fiscal year as described in the additional compensation table, attached hereto as "Exhibit A-1" and incorporated herein.

NOW, THEREFORE, in consideration of the mutual promises and covenants herein, the Parties agree to extend and amend the Agreement as follows:

- 1. The term specified in Section 3.1.2, <u>Term</u>, shall be extended for an additional nine-month period from October 1, 2022 to June 30, 2023.
- 2. The total compensation for services as specified in Section 3.3.1, <u>Compensation</u>, pursuant to this Amendment No. 3 shall be increased by an amount of **Four Hundred Forty-Seven Thousand**

Six Hundred Seventy-Nine Dollars (\$447,679) for work performed for the additional term period through June 30, 2023, thereby increasing the total not to exceed Agreement amount to Two Million Two Hundred Seventy Thousand Four Hundred Sixty-Six Dollars (\$2,270,466).

3. Except as amended pursuant to this Amendment No. 3, all provisions of the Agreement shall remain in full force and effect, and shall govern the services provided under this Amendment No. 3.
