WHEREAS, the City desires to specify that the City Manager or his/her designee has the authority to submit applications, accept funds, and take any other actions necessary regarding the City's actions pertaining to the CDBG program; and

WHEREAS, the authorization contained herein shall continue until rescinded by the City Council.

NOW, THEREFORE, the City Council of the City of Yorba Linda does hereby resolve, order and determine as follows:

<u>Section 1.</u> The foregoing Recitals are incorporated herein by reference in their entirety.

<u>Section 2.</u> The City of Yorba Linda authorizes the City Manager or his/her designee to execute, for and on behalf of the City of Yorba Linda, the necessary agreement(s) and/or any other documents or instruments required pertaining to the Community Development Block Grant program including, but not limited to, the annual Contract agreements between the City and the County of Orange ("County") and all other CDBG agreements with the County.

<u>Section 3.</u> The City of Yorba Linda authorizes the City Manager or his/her designee to submit applications, accept funds, and take any other actions necessary regarding the City's actions pertaining to the Community Development Block Grant program.

<u>Section 4.</u> The City Clerk shall certify to the adoption of this Resolution.
