#### AMENDMENT NO. 2 TO THE

#### **JUNE 1, 2021 AGREEMENT**

# STEADFAST SECURITY AND THE CITY OF YORBA LINDA FOR PRIVATE PATROL SECURITY GUARD SERVICE

**THIS AMENDMENT NO. 2** is made and entered into this 16<sup>th</sup> day of May 2023, by and between the City of Yorba Linda ("City") and Steadfast Security ("Consultant").

## **WITNESSETH:**

WHEREAS, the City and Consultant entered into an Agreement for Professional Services dated June 1, 2021 ("Agreement") to provide private patrol security guard service.

**WHEREAS**, the City desires to extend this Agreement for professional services through May 31, 2024.

**NOW, THEREFORE,** it is mutually understood and agreed by City and Consultant that the Agreement is hereby amended in the following particulars:

- 1. Section 3.1.2, Page 2, delete the expiration date of "May 31, 2023" and replace with "May 31, 2024."
- The total compensation for the scope of service pursuant to this Amendment No. 2 shall not exceed one-hundred twenty-five thousand dollars (\$125,000), unless otherwise approved in writing by the City.
- 3. Exhibit "C" of the Agreement entitled "Compensation" will be amended to reflect the revised security guard fees as provided on Attachment (A) of this amendment.

The balance of the Agreement will remain unchanged. Upon execution by City and Consultant, this Amendment No. 2, shall be made effective June 1, 2023.

### **COMPENSATION**

Total Hourly Costs (includes administrative and support costs):

## Effective June 1, 2023, through May 31, 2024:

Twenty-six dollars and eighteen cents (\$26.18) per hour for regular working hours. Thirty-nine dollars and twenty-seven cents (\$39.27) per hour for overtime and holiday hours.

Overtime incurred on holidays and requests for service based on short notice of less than 72 hours.

Overtime incurred on holidays, guards requested in excess of 2 (first two guards at regular rate, third guard and beyond at overtime rate), and requests for service based on short notice of less than 7 days.
