

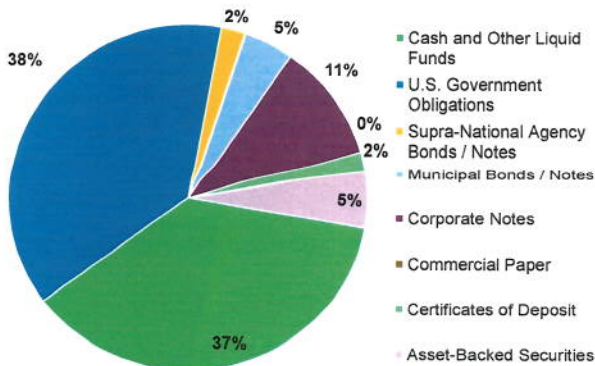

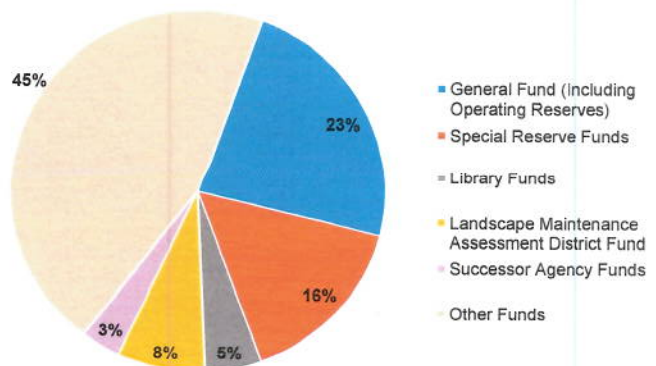

Composition of Pooled Investment Portfolio

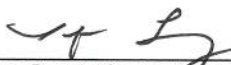


Pooled Investment Portfolio Balances by Fund

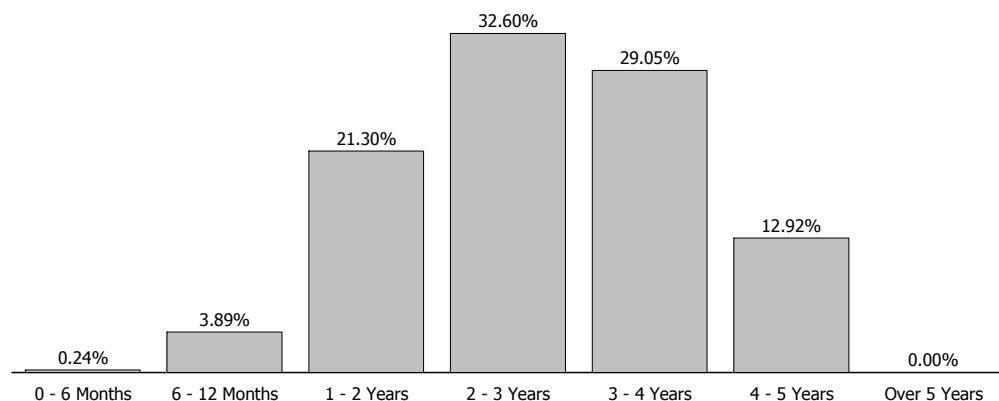

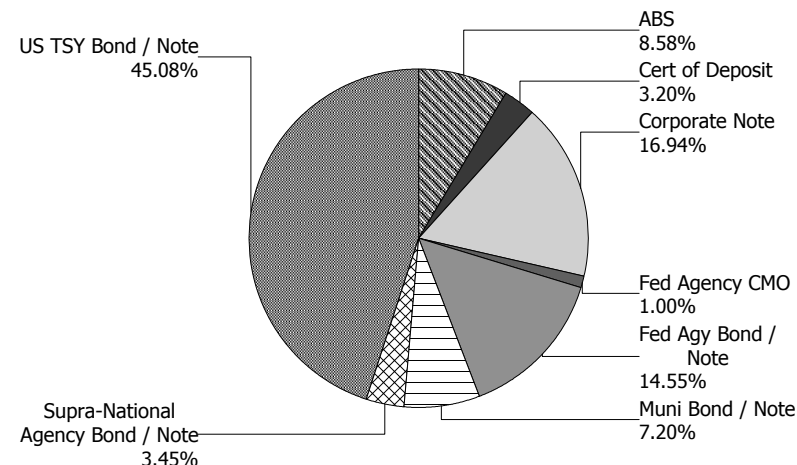

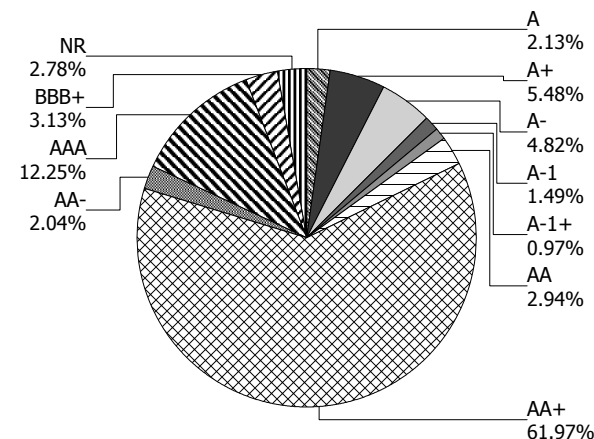
