CLOSED SESSION REPORT

Deputy City Attorney Larsen said there was no reportable action on the items discussed in Closed Session. Additionally, he said Council voted 4-0 to add an urgency item to the agenda under Consent Calendar as Item No. 10.1.

AMERICAN MUSLIM APPRECIATION AND AWARENESS MONTH

Mayor Gene Hernandez said although not on the agenda, he would like to present a proclamation recognizing August as American Muslim Appreciation and Awareness Month and invited Aliya Yousufi, Outreach Director for the Islamic Center of Yorba Linda and Mr. Noor Ahmed, Board Member for Marketing to the podium.

Council presented Ms. Yousufi and Mr. Ahmed with the proclamation and they thanked Council for the support and recognition.

<u>PUBLIC COMMENTS – ITEMS ON THE CONSENT CALENDAR OR ITEMS NOT ON THE REMAINDER OF THE AGENDA</u>

Tom Castanzo, resident, shared concerns about the landscape maintenance in Zone L1B and the poor quality of maintenance and street sweeping services.

Richard de Bruijn, resident, spoke about housing elements throughout the state and his experience at the last Resident Housing Policy Working Group. He also expressed concerns about state pensions and protecting taxpayers' dollars.

Natalie Levin, Volunteer Advocate for the Alzheimer's Association, spoke about the organization and provided alzheimer's and dementia statistics in Orange County and spoke of the importance of early diagnosis.

- b. Staff Report

Senior Community Preservation Officer Mary Lewis provided a PowerPoint presentation on the Program and a brief background on the number of non-compliant properties. On March 16, 2023 the City mailed 1,204 weed abatement notices to affected owners requesting abatement by May 25, 2023. As of the preparation of the staff report for this agenda, five properties remained out of compliance; however, as of today, only two properties remain out of compliance. This update will be reflected in Exhibit A of the proposed resolution for adoption. She concluded her report by discussing the remaining steps and options to abate the properties.

<u>CITY MANAGER'S REPORT/MAYOR'S REPORT/MATTERS PRESENTED BY</u> COUNCILMEMBERS/ OTHER AGENCY REPORTS

City Manager Mark Pulone spoke about the City's Know Your Way program, aimed at helping residents know their evacuation route and help them preplan. He said the City will be hosting informational meetings, with the first one scheduled on Saturday, August 26th at 10:00 a.m. at the Yorba Linda Community Center. He said more meetings will be scheduled, including one or two, in the east end of the City. With respect to the concerns from Mr. Castanzo, he said staff will share the maintenance photos he provided and follow up accordingly with contractors. He said street sweeping is provided under the contract for waste management services with Republic Services, and staff will contact them accordingly as well. With respect to Mr. de Bruijn's comments, he said the City looks forward to sharing the recommendations from the Resident Housing Policy Working Group with residents and will do so at future community meetings. He said staff would be happy to work with Ms. Levin in order to arrange for the Alzheimer's Association to offer information and future events.

Councilwoman Janice Lim attended National Night Out on August 2nd and said the event was well attended. She expressed her gratitude to Yorba Linda Police Services for all their hard work.

Councilman Carlos Rodriguez expressed his appreciation of all first responders and said it was great to interact with all of our local heroes at National Night Out. He attended the Placentia-Yorba Linda Unified School Districts State of the District.

Mayor Pro Tem Tara Campbell attended the Interfaith Food Packing Event on August 12th at the Yorba Linda Islamic Center in partnership with the Church of Jesus Christ of Latter-Day Saints and said several packages were put together that day for those in need.

Mayor Hernandez spoke about the Citizen of the Year program and said the City is currently accepting nominations through September 8, 2023. He said the program aims to honor individuals who go above and beyond for the community. He also announced that Yorba Linda schools will be back in session in the next few weeks and encouraged local students to study hard and he reminded drivers to be extra careful when driving on city streets, especially at crosswalks and intersections. Mayor Hernandez concluded his comments by announcing the upcoming Movies in the Park & Concerts in the Park. He said on Saturday night the City will be showing Lightyear, and on Sunday will be the last Concert in the Park of the season, with The Reflexx playing 80's Alternative music. Mayor Hernandez said both events are free and more information can be found on the City's website.

ADMINISTRATIVE REPORTS

12. ORDINANCE NO. 2023-1107 – REVISIONS TO CHAPTER 3.04 OF THE MUNICIPAL CODE GOVERNING PROCUREMENT AND APPROVAL OF REVISIONS TO CITY COUNCIL POLICY F-1 GOVERNING CHANGE ORDERS AND AMENDMENTS

Finance Director Honeywell shared a brief PowerPoint on this item. She said Chapter 3.04 of the Municipal Code was last updated in 2020 and needs various modifications, modernizations and clarifications to improve the efficiency of the City's procurement practices. One such Municipal Code change is clarifying language as to when City Council approval of contract extensions are required, unless otherwise approved by Council, agreements and contracts will not extend beyond five years. She also spoke of proposed changes to City Council Policy F-1 and she highlighted some of the changes to the Municipal Code and Policy F-1. Director Honeywell concluded her presentation with the staff recommendation.

Tom Castanzo, resident, said 5 years for a contract is too long and said 3 years is the average and believes it should be voted on, not just with City Manager authority to approve extensions.

Mayor Pro Tem Campbell responded to Mr. Castanzo and said Council does vote on the contracts and one of the things she did when she began serving on Council was to lower the threshold for City Manager approval.

13. TENTH AMENDMENT TO CITY MANAGER EMPLOYMENT AGREEMENT

Assistant City Manager Dave Christian said City Manager Pulone's original agreement was entered into on July 2, 2013 and said it has since been amended nine times. He discussed the proposed Tenth Amendment updates pertaining to terms of employment which included a standard cost of living (COLA) increase of 2.0% as received by all City

employees, plus an additional salary increase of 5.0% based on exceptional merit effective as of July 1, 2023.

It is recommended that the City Council review and approve the "Tenth Amendment Employment Agreement" ("Tenth Amendment") that amends the City Manager's employment agreement with the City and appropriate the necessary amounts in the FY 23-24 budget.
