WHEREAS, the City management and employee representatives have met and conferred in good faith the reach an agreement to provide certain classes of the City's employees with salary increases and other benefits pursuant to Government Code Section 3500 et seq.; and

WHEREAS, the City desires to rescind Resolution No. 2018-5589 and adopt Resolution No. 2021-5774; and

WHEREAS, the City desires to approve the negotiated Memorandum of Understanding (Attachment A) with the Mid-Management Employees of the City of Yorba Linda represented by the City Employees Associates which provides for certain salary increases to its employees as provided in the Memorandum of Understanding dated October 1, 2021 to June 30, 3024; and

NOW, THEREFORE, **BE IT RESOLVED** by the City Council of the City of Yorba Linda as follows:

<u>Section 1.</u> Classification and compensation language previously presented in the Resolutions has been placed in the Memorandum of Understanding. The Memorandum of Understanding will be the governing document for classification and compensation for Mid-Management employees represented through the bargaining unit.

<u>Section 2.</u> Except as otherwise specified to the contrary in this Resolution of the Memorandum of Understanding, all provisions shall be effective as of October 1, 2021 pursuant to Minute Order action of the City Council.

<u>Section 30 – Rescind Previous Resolution:</u> Resolution No. 2018-5590 is hereby rescinded in its entirety.
