A RESOLUTION OF THE PLANNING COMMISSION OF THE CITY OF YORBA LINDA DETERMINING GENERAL PLAN CONFORMITY PURSUANT TO REQUIREMENTS OF STATE GOVERNMENT CODE SECTIONS 65103(C) AND 65401 FOR THE 2025-2032 CAPITAL IMPROVEMENT PROGRAM

WHEREAS, the City of Yorba Linda is proposing to approve the 2025-2032 Capital Improvement Program (CIP), identifying the capital improvements proposed for construction over the next seven years; and,

WHEREAS, State Government Code Sections 65103(C) and 65401 stipulate that prior to authorization or construction of public works projects, the planning agency of the jurisdiction in which said property is located shall review and report as to conformity of said public works with the adopted General Plan of the local jurisdiction; and,

WHEREAS, this matter is not considered a "project" pursuant to the requirements of the California Environmental Quality Act (CEQA); and,

WHEREAS, this project involves no repeal, amendment, or adoption of all or any part of the land use planning policy documents as specified in Section 18.01.020 of the Yorba Linda Municipal Code, this project is exempt from the provisions of Chapter 18.01 of the Yorba Linda Municipal Code, also known as the "Yorba Linda Right-to-Vote Amendment;" and,

WHEREAS, this matter was considered by the Yorba Linda Planning Commission at a regular meeting on May 14, 2025; and,

WHEREAS, after consideration of the staff report and all of the information, testimony, and evidence presented at the Planning Commission meeting, the Yorba Linda Planning Commission DOES HEREBY FIND as follows:

A. The Yorba Linda General Plan includes policy guidance in relation to provision of public streets, parks, and other public facilities. The 2025-2032 CIP contains 48 projects that reflect the City's capital needs for the stated term. In reviewing the CIP project list, no inconsistencies between the proposed public works projects and stated goals and policies in the General Plan have been identified. Based on the foregoing, the proposed 2025-2032 CIP is in conformance with the Yorba Linda General Plan, as required by State Government Code Section Nos. 65103(C) and 65401.

NOW THEREFORE BE IT RESOLVED that the Yorba Linda Planning Commission does hereby determine that the proposed 2025-2032 Capital Improvement Program (CIP) is in conformance with the Yorba Linda General Plan, as required by State Government Code Section Nos. 65103(C) and 65401.
