

## RESOLUTION NO. 2021-5776

### **A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF YORBA LINDA AMENDING MASTER USER FEES & CHARGES RESOLUTION NO. 2021-5745 TO ADJUST RATES FOR ELECTRIC VEHICLE CHARGING UNITS.**

**WHEREAS**, the City Council desires to amend the master list of user fees & charges to implement a new fee structure for electric vehicle charging units at the Library and Cultural Arts Center and ratify the existing rates for the Town Center Parking Structure; and

**WHEREAS**, on May 18, 2021, adjustments to the City's User Fees and Charges were last adjusted through the adoption of Resolution No. 2021-5745 by the City Council.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Yorba Linda as follows:

#### Section 1. Miscellaneous Fees

The fees outlined in Attachment A to this Resolution are hereby established for the Miscellaneous Fee Section of the City's Master List of User Fees and Charges.

#### Section 2. Severability.

If any section, subsection, sentence, clause, phase, or portion of this Resolution is for any reason held to be invalid or unconstitutional by the decision of any court of competent jurisdiction, such decision shall not affect the validity of the remaining portions of this Resolution. The City Council hereby declares that it would have adopted this Resolution, and each section, subsection, subdivision, sentence, clause, phrase or portion thereof, irrespective of the fact that any one or more sections, subsections, subdivisions, sentences, clauses, phrases or portions might subsequently be declared invalid or unconstitutional.

#### Section 3. Effective Date.

The fees & charges authorized in this Resolution shall become operative on Monday, January 3, 2022.

**ATTACHMENT A  
ELECTRIC VEHICLE CHARGING UNIT SCHEDULE**

Town Center Parking Structure Electric Vehicle Charging Rates:

- Tier 1 rate is not to exceed \$0.25 per kWh (kilowatt hour) for energy consumption and \$1.00 per hour for use of the space for the first four (4) hours of use.
- Tier 2 rate is not to exceed \$0.25 per kWh for energy consumption and \$4.00 per hour for use of the space.

Library and Arts Center Electric Vehicle Charging Rates:

- The rate is not to exceed \$0.25 per kWh (kilowatt hour) for energy consumption and \$1.00 per hour for use of the space.
- Once a vehicle is fully charged, the charger will turn off and no other fees will be charged to the customer.
